Water, electricity, gas, cable TV and weekly housekeeping are included in the rental payment.

Damages and long distance telephone charges will be deducted from the security deposit and the balance forwarded to the Lessee. Amounts in excess of the deposit will be paid promptly by the Lessee within 5 days after any bills related to this rental are presented to the Lessee.

Lessee's personal property shall be at the risk of the Lessee or other owner thereof and Phil, LLC shall not be liable for any damages to said property or to the Lessee or other occupants arising from any act by the occupants or by any other person whomsoever or any other cause whatsoever.
